The following are procedures for Public Buyers, please read carefully before purchasing a vehicle.

- **\$20 cash non refundable registration fee**
- **\$500 CASH ONLY deposit is required to bid on each vehicle. The deposit will be applied towards the purchase of a vehicle. If no vehicle is purchased, deposit will be refunded upon presentation of BOTH bidder badges to the Front Office. If BOTH bidder badges are not presented, a \$200 charge will be assessed.**
- **NO INDIVIDUAL UNDER THE AGE OF 18 ALLOWED on premises for auction or inspection.**
- **ADESA Washington DC reserves the right to bar any public buyer from participating in the auction.**
- **Bidder registration will require your full name, valid address, phone number and valid driver's license.**
- **Under federal law, the registrant must be the purchaser of the vehicle. Title will be transferred to the registrant only.**
- **Not all vehicles are available to the public. Please review the list of vehicles offered to the public before registering.**
- **Inspection available on Wednesday morning prior to start time of sale (registered bidders only) in the designated area only. Repossession vehicles offered to the public are marked with a "P" sticker in the bottom corner of drivers side windshield.**
- **Public is NOT PERMITTED to drive any vehicles. Bidder may start vehicle, but may not move vehicle from parked position.**
- **Any purchase over \$500 must be paid with CASH or CASHIER CHECK made payable to ADESA Washington DC. Second or third party endorsements are not permitted.**
- **Balance required by 5:00pm day of sale (Wednesday). If balance is not paid in full by 5:00pm on Wednesday, a \$175 late fee will be assessed. If balance remains unpaid by 5:00pm on Thursday the vehicle sale will be voided and cash deposit will be forfeited.**

- Please note that a buyer fee will be attached to each vehicle that is purchased. The buyer fee varies with the price of the vehicle. Buyer fees start at \$190 and increase based on the purchase price of the vehicle.
- Public is NOT PERMITTED to purchase vehicles on an "If Sale".
- After receipt of the balance in full for the vehicle, the title will be released to you. You must take it to the Department of Motor Vehicles to transfer into your name. **NO VEHICLES WILL BE RELEASED FROM THE PREMISES UNTIL PROOF OF REGISTRATION AND PROOF OF INSURANCE IS SHOWN TO ADESA.** This means that the title must be in your name.
- All public bidders must leave the sale arena immediately following the repossession sale. If an individual does not leave within 10 (ten) minutes after the end of the sale, the cash deposit will be forfeited.
- ADESA Washington DC does not distribute temporary tags.
- ADESA Washington DC is not responsible for any vehicle(s) that are left on ADESA premises.
- **ALL SALES ARE FINAL.**
- **AS IS – NO WARRANTY:** The Auction and seller (lending institution) assume no responsibility for any repairs.
- Buyer realizes that promotional warranties and/or inspections sanctioned by the Auction and/or seller (lending institution) are null and void.
- Auction and seller (lending institution) assume no responsibility or liability for mechanical or structural damage. Buyer assumes responsibility for damages to the vehicle or for injury caused by the vehicle after payment is made.
- Buyer realizes and agrees that ADESA Washington DC and seller (lending institution) are not responsible for the accuracy of the odometer, the reading of the odometer, or the odometer statement.
- Police and Security will enforce all rules of the Auction.
